Better Crazy than Sick: Regulating Mental Health With or Without the Affordable Care Act

This presentation explains the regulatory challenges facing mental health providers in California, ranging from acute psychiatric hospitals to rehabilitation clinics. The federal government and California have increased spending for mental health at never before seen levels. At the same time, payers and federal/state agencies challenge the business of mental health care in equal proportion. To represent these providers, attorneys must understand some history, the amount of money at issue, as well as regulatory and payer challenges along the way.
