Section 1011: Federal Reimbursement of Emergency Health Services Furnished to Undocumented Aliens

This fact sheet informs ambulance services, hospitals including Critical Access Hospitals (CAHs), physicians, and Indian Health Service (IHS) facilities in specific states that funds remain available for certain emergency health services provided to undocumented aliens. As of February 2013, the Section 1011 program disbursed \$945.5 million in provider payments in response to over 1.5 million payment requests.

As of May 22, 2013, 28 states exhausted their Section 1011 funds. Providers located in these states should stop submitting Section 1011 payment requests.



How Did the Section 1011 Program Allocate Funds?

The Section 1011 program allocated funds by state, with one-third of the total funds divided among the six states with the largest number of undocumented alien apprehensions and two-thirds divided among all 50 states and the District of Columbia, based upon their relative percentages of the total number of undocumented alien residents. Two-thirds of the funds are divided among all 50 states and the District of Columbia, based on their relative percentage of undocumented aliens.



One-third of the funds are divided among the six states with the largest number of undocumented aliens for each Fiscal Year.

Am I Eligible to Enroll in the Section 1011 Program?

The Section 1011 program may include payments for the following providers:

- Ambulance service providers;
- Hospitals, including CAHs;
- Indian Health Service facilities; and
- Physicians.


Physicians and ambulance service providers do not need to enroll in the Medicare Program to enroll in the Section 1011 program.

How Do I Enroll in the Section 1011 Program?

You may enroll in the Section 1011 program by submitting an application to Novitas Solutions, Inc., which is currently the national contractor for the Section 1011 program.

Novitas Solutions processes all current program enrollments. NOTE: Medicare Claim Administration Contractors do not administer nor process Section 1011 enrollment applications or payment requests. Instead, contact Novitas Solutions, Inc., the Section 1011 national contractor, for all of your Section 1011 needs.



Which Services Does the Section 1011 Program Reimburse?

The Section 1011 program may reimburse services furnished to the following types of patients:

- Aliens paroled into a United States port of entry for the purpose of receiving eligible services;
- Mexican citizens permitted to enter the United States on a laser visa, issued in accordance with the requirements of regulations prescribed under the Immigration and Nationality Act; and
- Undocumented aliens.

Reimbursable services are the same as those required by the Emergency Medical Treatment & Labor Act (EMTALA), as well as related hospital inpatient, outpatient, and ambulance services. The Section 1011 program does not make payment for services reimbursed through insurance or otherwise.
